

Once the electronic form opens, you have 2 possibilities depending on your case:

1: if you are not concerned by the contribution, tick the box "I do not distribute medical devices..." and then click on "Save".

2: if you are concerned by the contribution, enter the 3 amounts, click on "add a file" to upload the declaration and then click on "Save".

2. I have access to the portals but not to contributions, what should I do?

Each application requires a specific access, which means that the user who needs to access the contribution application must have the "Contribution" specific access.

To access it, the chief access manager must log in to the [social security website](#) (see chapter 4 of the [manual](#))

He must then check whether access to "Contributions" has been ticked for the user in question.

Applications sécurisées

- Autocontrôle (AFMPS)
Autocontrôle permet aux inspecteurs de l'AFMPS d'établir un score de risque pour les acteurs des soins de santé.

- Source authentique des Représentants Autorisés
L'application SARA est une application web mise à disposition des entreprises belges afin qu'elles puissent y gérer leur répertoire de fabricants ou de fournisseurs de produits médicaux pour lesquels elles vont faire des demandes de mise sur le marché belge ou d'obtention de certificats à l'exportation. Les sites de production des fabricants sont également gérés dans SARA.
- Portail MEDSEIP
Portail d'accueil et de communication des acteurs en collaboration avec l'Agence Fédérale des Médicaments et des Produits de Santé
- Source authentique des acteurs (AFMPS)
L'application SAA permet aux entreprises d'enregistrer les coordonnées de leur entreprise à l'afmps. C'est une application web qui est mise à disposition des entreprises afin qu'elles puissent se connaître à l'AFMPS.
- Source Authentique des Activités et Classes
La Source Authentique des Activités et Classes, SANAC, est une application qui permet aux entreprises d'enregistrer leurs activités (distribution, fabrication, importation, services) et classes d'activités électroniquement à l'Agence Fédérale des Médicaments et Produits de Santé (AFMPS).
- Source authentique des certificats à l'exportation
L'application SACEX est une application web mise à disposition des entreprises belges afin qu'elles puissent y faire leur demande de certificats à l'exportation.
- Source Authentique des Dispositifs Médicaux
La Source Authentique des dispositifs médicaux, SADM, est une application qui permet aux entreprises (distributeurs et fabricants) d'enregistrer leurs dispositifs médicaux électroniquement à l'Agence Fédérale des Médicaments et Produits de Santé (AFMPS).
- Tableau de bord de monitoring eHealth
Tableau de bord de monitoring eHealth pour le contrôle des SLA des divers services eHealth et des services présents sur l'eHealth bus.
